

# RELEASE FROM LIABILITY AND INDEMNIFICATION AGREEMENT

This Release form Liability and Indemnification Agreement is made and entered into by and between Silverwood Farm, LLC, Lisa Froehlig and employees of Silverwood Farm Herein referred to as "Silverwood Farm" and

If Rider/Handler is a minor, the parent or guardian executes this document on Rider/Handler's behalf.

NOTICE: A person who is engaged for compensation in the rental of equines of equine equipment of tack of in the instruction of a person in the riding or driving of an equine or in being a passenger upon an equine is not liable for the injury or death of a person involved in equine activities resulting from the inherent risks of equine activities, as defined in section 895.481 (l)(e) of the Wisconsin Statutes.

In consideration of the covenants, conditions and terms hereof and for other good and valuable consideration, it is agreed as follows:

1. **Acknowledgement of Inherent Danger.** Rider acknowledges that there are dangers and risks of injury inherent in equestrian activities, including but not limited to bodily injury and harm to a Rider, horse and spectator. With full knowledge of the risks and that there are alternative places to participation equine activities, the Rider freely and without coercion enters into this Agreement. It is expressly understood that the Rider would not be permitted to engage in equestrian activities at Silverwood Farm without the executed Release.
2. **Assumption of Risk.** Rider agrees to assume any and all risks involved in or arising from Rider's use of or presence upon Silverwood Farm property and facilities including, without limitation but not limited to: The risks of death, bodily injury, property damage, falls, kicks, bites, collisions with horses, vehicles, or stationary objects, fire or explosion, the unavailability of emergency medical care and/or deliberate act of another person.
3. **Release.** Rider does hereby forever release, acquit and forever discharge Silverwood Farm, it's owners, employees, agents and all other persons, corporations, associations, or partnerships from any and all claims, actions, causes of action, demands, rights, damages, costs, loss of service, expenses and compensation whatsoever which Rider ay hereinafter incur on account of or in any way arising out of bodily injuries an/or property damage of consequences thereof resulting from any accident, casualty or event involving the Rider and arising out of equestrian activities on or about Silverwood Farm, Camp Lake, WI.
4. **Covenant not to Sue.** Rider now and forever covenants ad agrees not to sue Silverwood Farm or an other release party and to refrain forever from instituting or in any way proceeding upon an claim, cause of action, judgment, suit, or proceeding of any kind of nature whatsoever, whether known or unknown which the Rider has released pursuant to this Agreement.
5. **Indemnification.** Rider hereby agrees to indemnify and hold harmless Silverwood Farm against any and all claims, damages, costs, or expenses whatsoever including attorney's fees and court cost, as a result of any accident or injury which might occur while the Rider is engaging in equestrian activities and use of the facilities at Silverwood Farm, Camp Lake, WI.
6. **Compliance of Rules.** Rider agrees to abide by all of the Rules of Silverwood Farm.
7. **Use of Riders Horse.** If Rider is using Rider's horse, the horse shall be free form infection contagious or transmittable disease. Silverwood Farm reserves the right to require the Rider to remove Rider's horse if, in the opinion of the managing agent for Silverwood Farm, the horse in not in proper health, is dangerous, or is otherwise unacceptable.
8. **Insurance** Rider acknowledges that Silverwood Farm provides no insurance coverage for the benefit of Rider and that it is Rider's responsibility to carry full and complete insurance on Rider, Rider's personal property and Rider's horse.
9. **Miscellaneous.** This Document contains the entire agreement of the parties with respect to the matters set forth in this Release. In any provision of this document is determined by a court of competent jurisdiction to be invalid, illegal or unenforceable, the balance hereof shall remain in effect to the fullest extent enforceable by law and if any provision is inapplicable to any person of circumstance, it shall nevertheless remain applicable to all others persons and circumstances. The agreements hereunder are not assignable and non-transferable. This Release has been entered in the state of Wisconsin and shall be enforced and interpreted with the laws of the State of Wisconsin.
